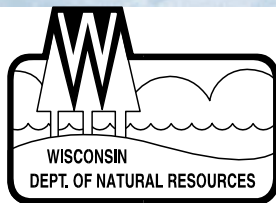

**2005-2006 Snowmobile Program Report
Summary**

The 2005-2006 Snowmobile Program Report was compiled from the 36 fatal investigations and other data collected during the fiscal year 2005-2006 (a fiscal year runs from July 1 – June 30).

Conservation Wardens investigate all fatal snowmobile incidents and as such, Wisconsin law requires that a conservation warden or law enforcement officer be notified immediately of any snowmobile incident that results in an injury requiring medical treatment by a physician. In addition, the operator(s) involved in these reportable incidents must file a written report with the Department of Natural Resources within 10 days, in so far as they are capable of doing so.

FATAL INCIDENT CAUSES

The primary type of crash causing the victim's death continues to be striking a fixed object such as trees, shorelines, or ice/rock. The secondary type of crash leading to the victim's death this reporting period is tied between collision with another snowmobile or truck, and rollover. The leading contributing factors were alcohol and excessive speed.

There were 25 (27 the previous year) fatal crashes that investigators directly identified speed as a contributing factor to the death of the operator/passenger. Of the 25 speed related fatalities, 20 of those that died had consumed alcohol or 80% (75% the previous year) of the speed related victims.

Alcohol was identified as another major contributing factor. The 2003-04 laws expressly stated a person is under the influence of alcohol once their blood alcohol level reaches 0.08; however, for the purposes of this report, any alcohol level identified in the coroner's report (by percent) is considered to be a contributing factor.

Sixty-four percent (23 of the victims) of the known toxicology reports performed show alcohol was consumed by the victim. Toxicology examinations were not performed on five victims; eight victims had no alcohol present. A review of the alcohol involved fatalities show that no victims had less than 0.04 alcohol levels. Five percent of the victims that consumed alcohol showed levels less than .08%. Thirty-seven percent of the victims that consumed alcohol had levels from 0.08 to 0.199%. Fourteen percent of the alcohol related victims were reported at 0.20 or above, with one victim result at 0.292.

WHO WAS INVOLVED

Thirty-four of the 36 victims were male. Victim ages ranged from 13-71 years, with the average age 36.2 years old; last season's average age was 33.7 years. The largest percentage of victims was age 30-49 years with 50%. The second largest age group was age 21-29 years at 17%. One child under 16 was killed this reporting period. Of the 36 fatal incidents, 26 of the victims were Wisconsin residents while 4 were from Illinois, 3 from Minnesota, and 1 from Alabama, Indiana and Texas. The majority of the victims (25) had not received Wisconsin Snowmobile Safety Training. Of the 36 victims, 33 were known to have been wearing a helmet, 3 were not wearing a helmet.

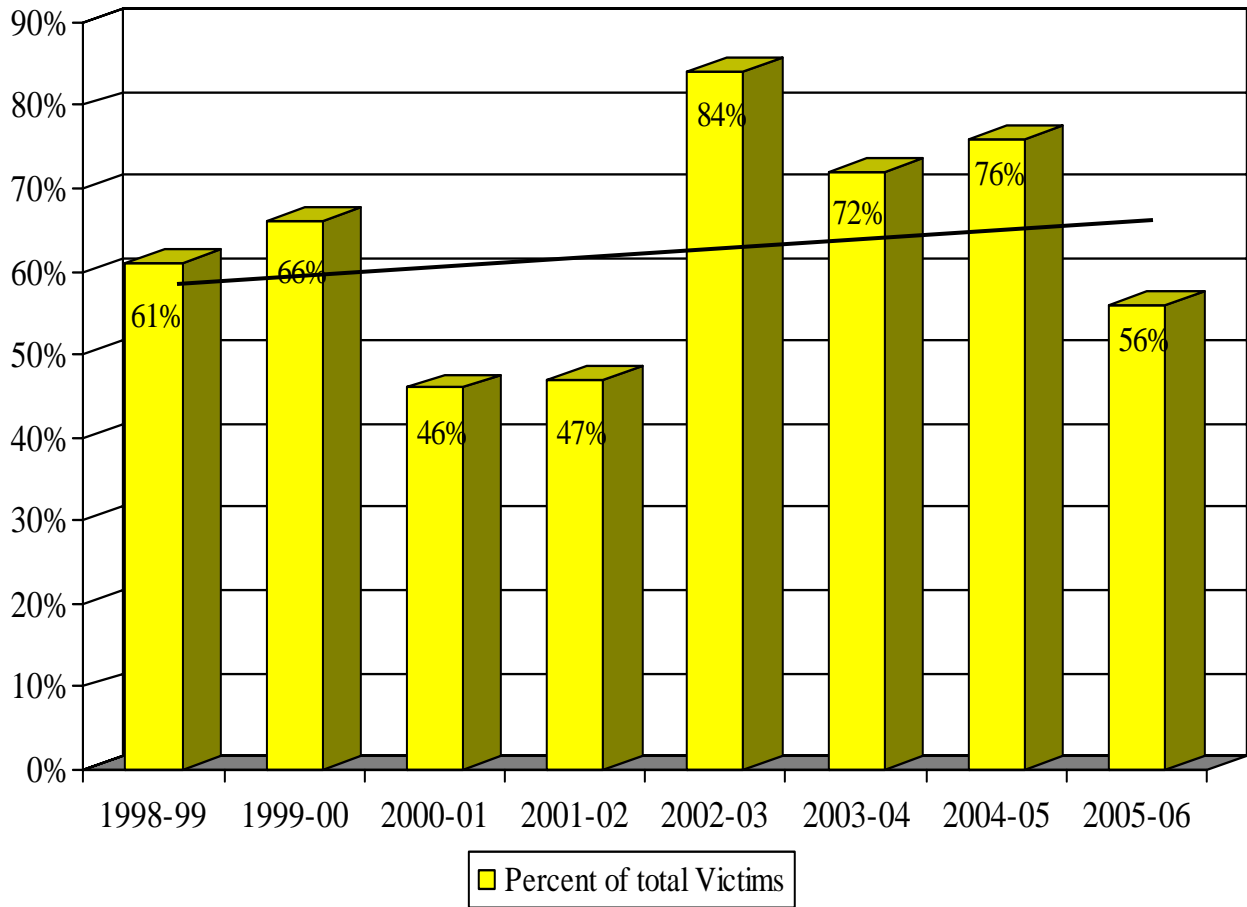
WHEN DO THE INCIDENTS OCCUR

The highest percentage of fatalities continues to occur on a Saturday with fourteen victims, Tuesday with six, Sunday with five and Friday with four. Most of the fatal crashes (8) occurred between 10:00PM-12:00PM.

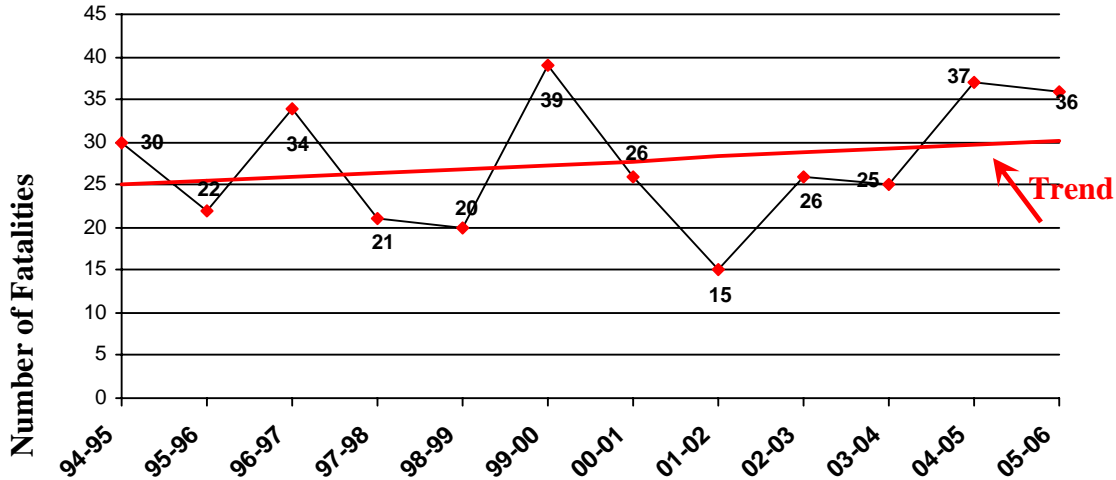
LOCATION OF INCIDENTS

The top location of fatal incidents was on the trails with sixteen victims and on the roads involving nine victims, followed by lakes with eight, on a river with two and one victim on private property.

Percent of Victims Killed Showing Alcohol as a Contributing Factor

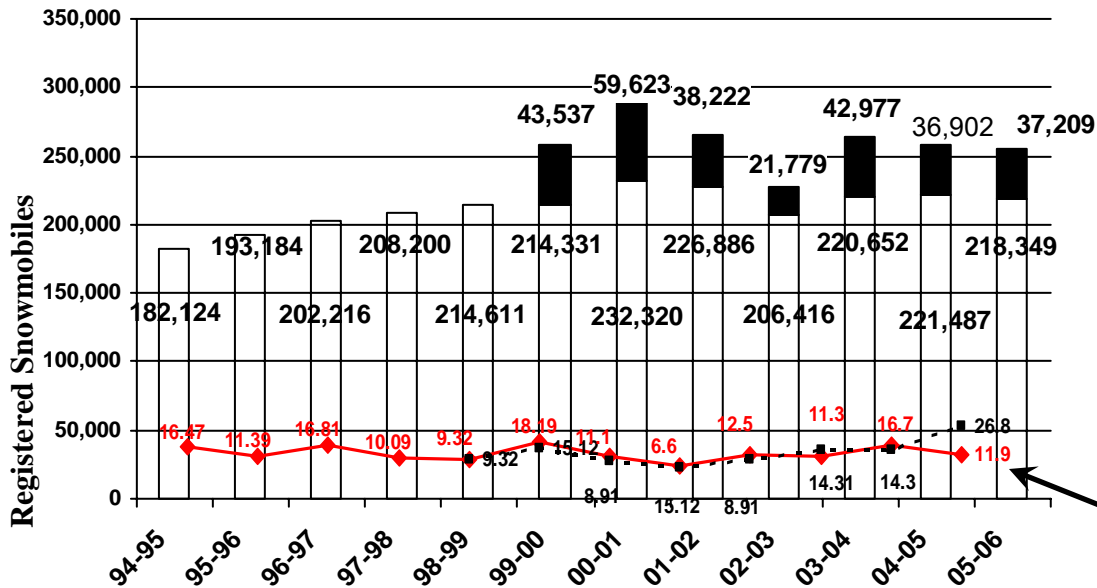


History of Snowmobile Fatalities



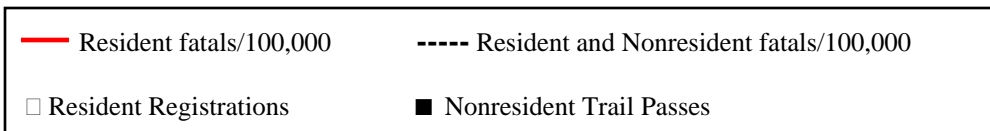
The 12-year fatal average is 27.6 deaths per year.

Snowmobile Fatality Rate to Number of Snowmobiles Registered



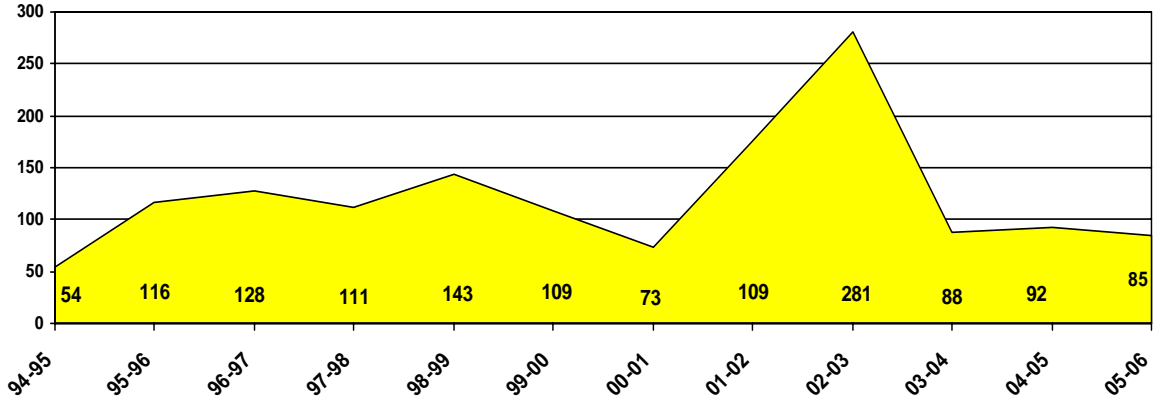

Fatals per 100,000 Registrations.



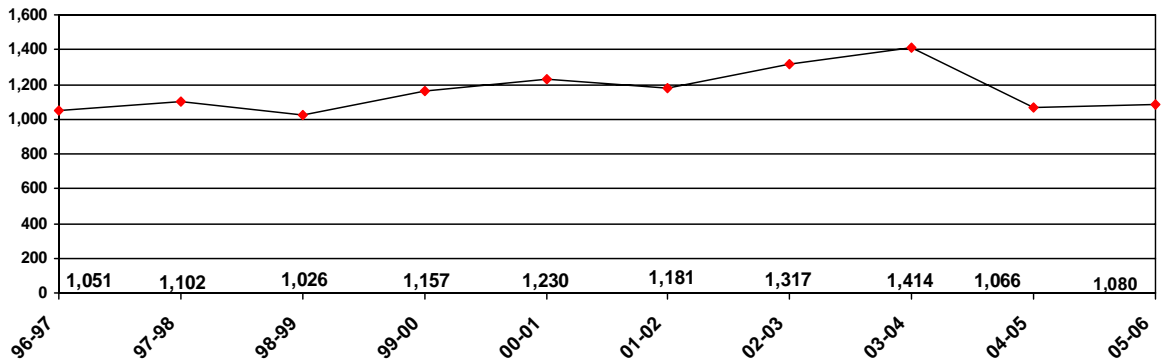
History of Newly Recruited Snowmobile Education Instructors

The total number of active instructors for 2005-2006 was 1,080.



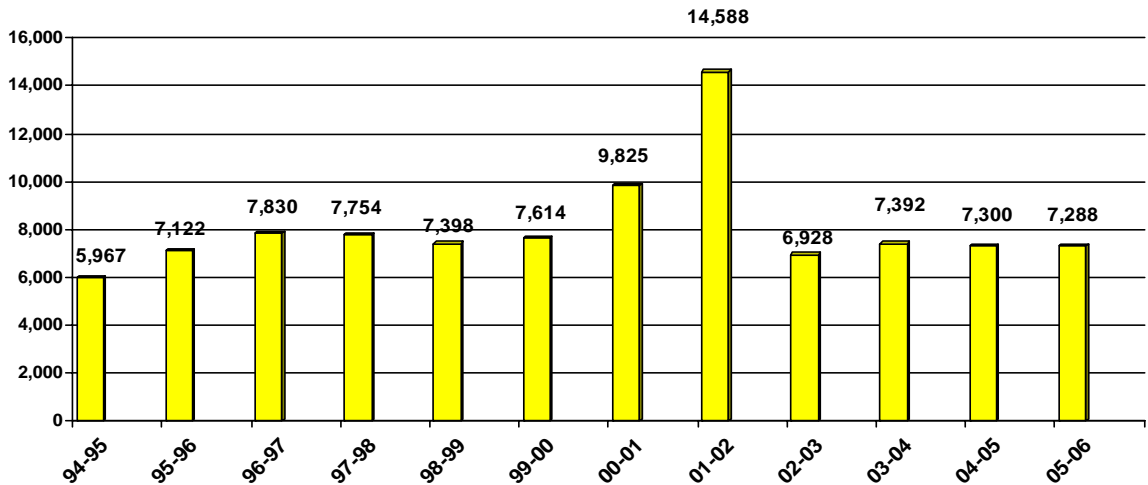
History of Active Snowmobile Instructors

Over 253,910 students have been certified by volunteer instructors.



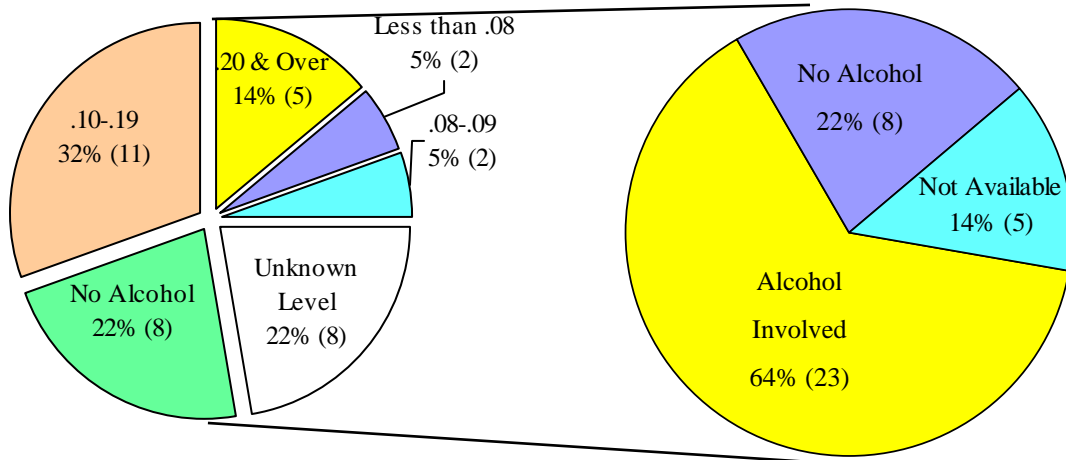
History of Certified Snowmobile Students

The 2005-2006 season showed that alcohol was a contributing factor in 64% of all fatalities.

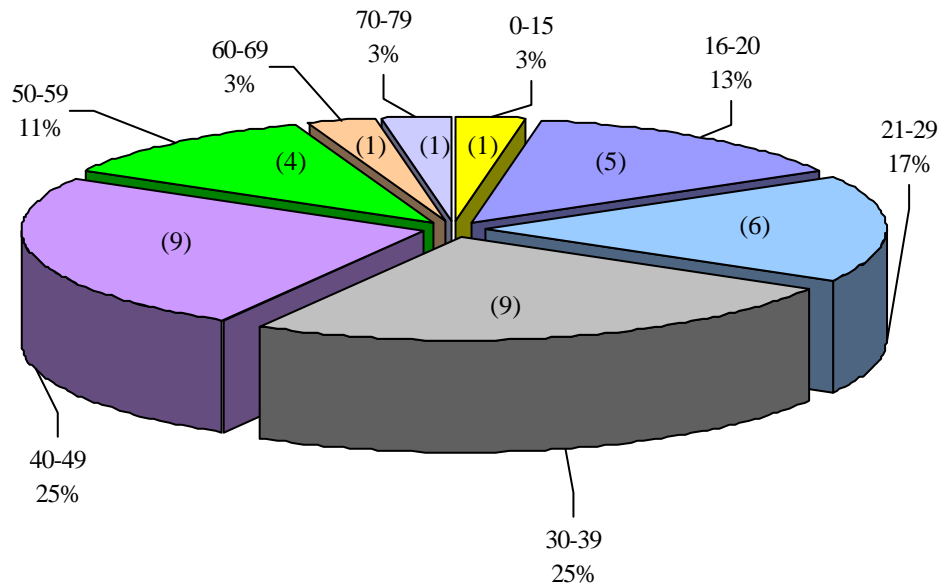

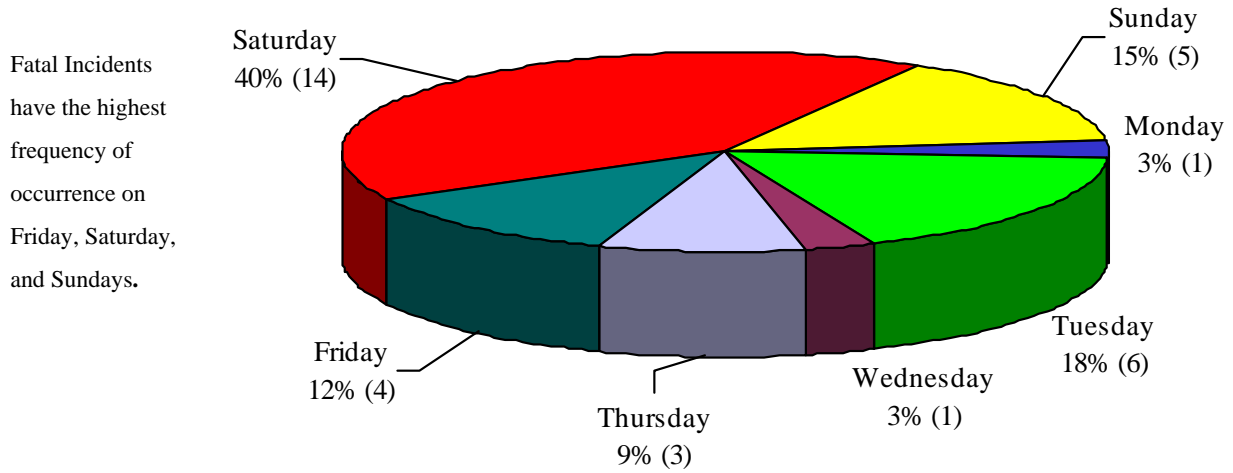
2005-2006 Age of Snowmobile Fatality Victims

Twenty-four of the 36 victims were male.

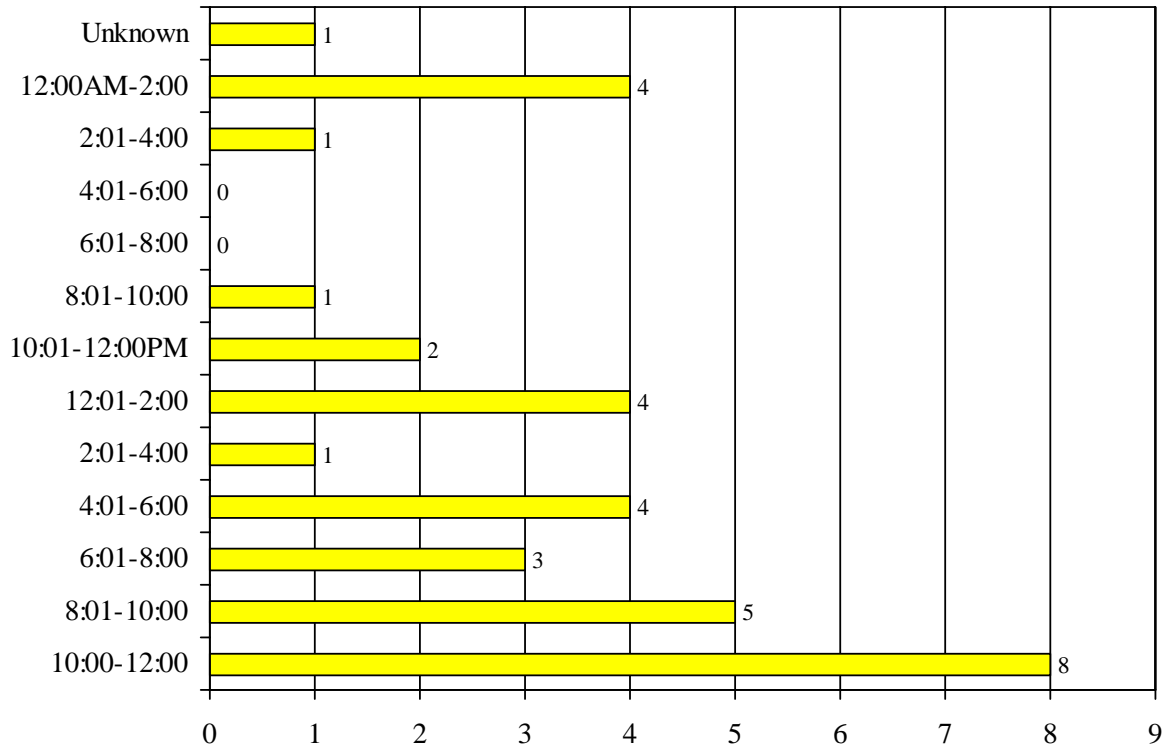
The average age for the victims killed was 36.2 years old as compared to 33.7 years in 2004-2005.



2005-2006 Snowmobile Fatal Incidents by Day of Week

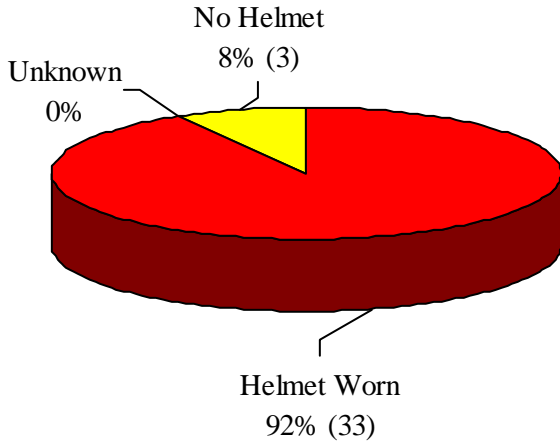


2005-2006 Snowmobile Fatal Incident by Time of Day

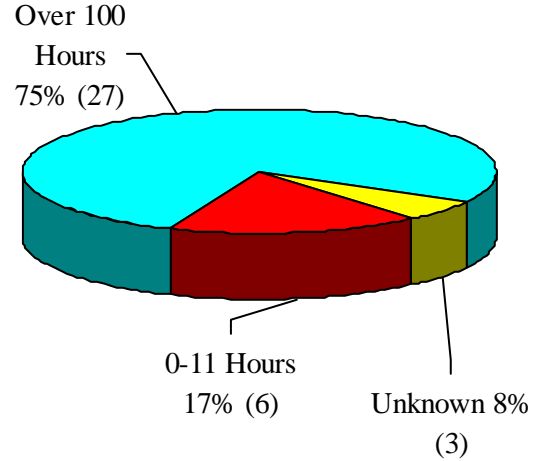

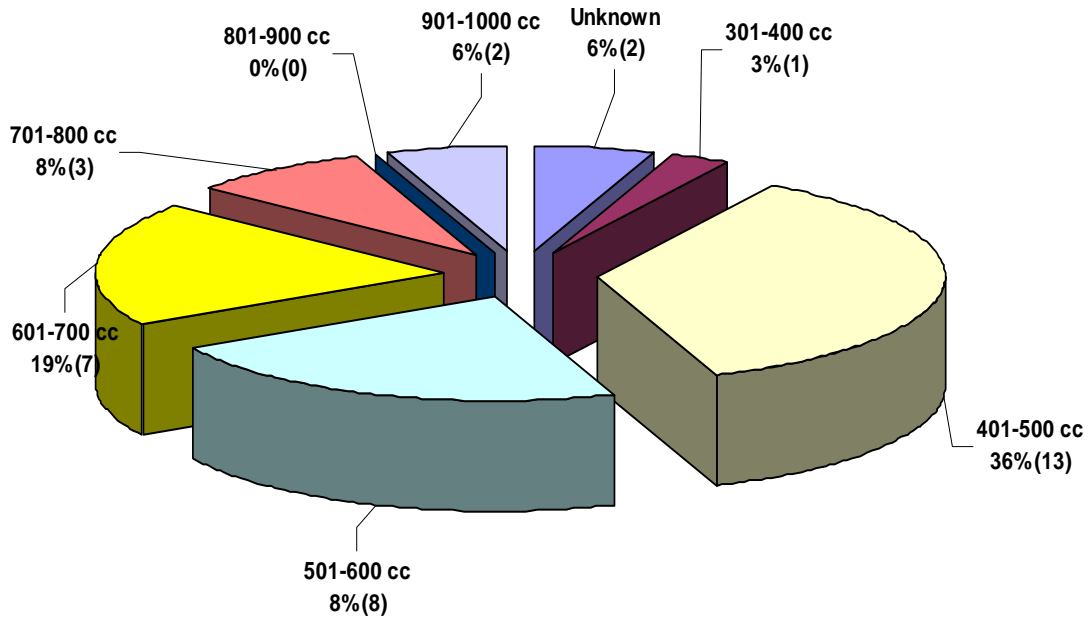

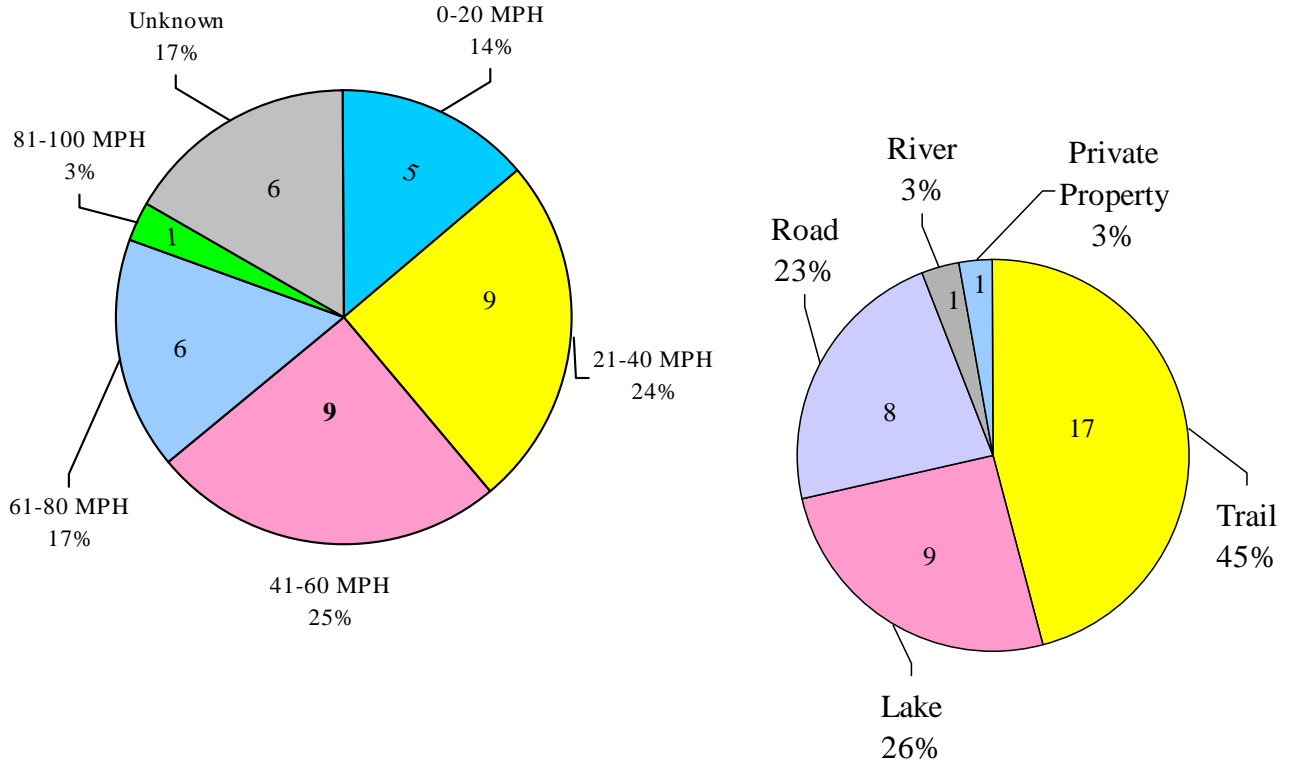

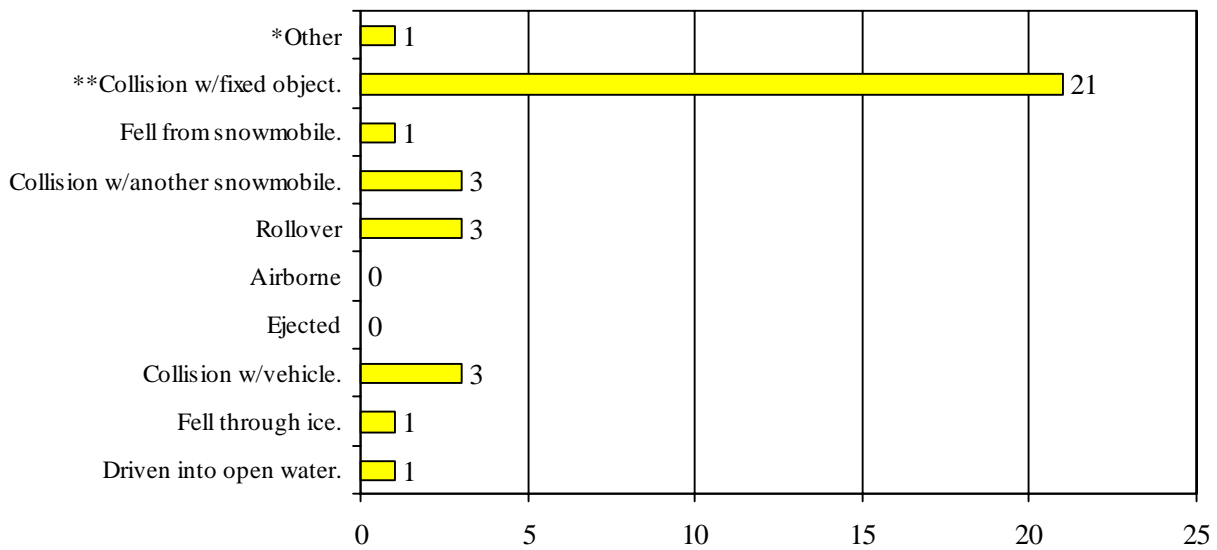
2005-2006 Snowmobile Engine Displacement for Machines Involved in Fatal Snowmobile Incidents

2005-2006 Fatal Snowmobile Incidents Type



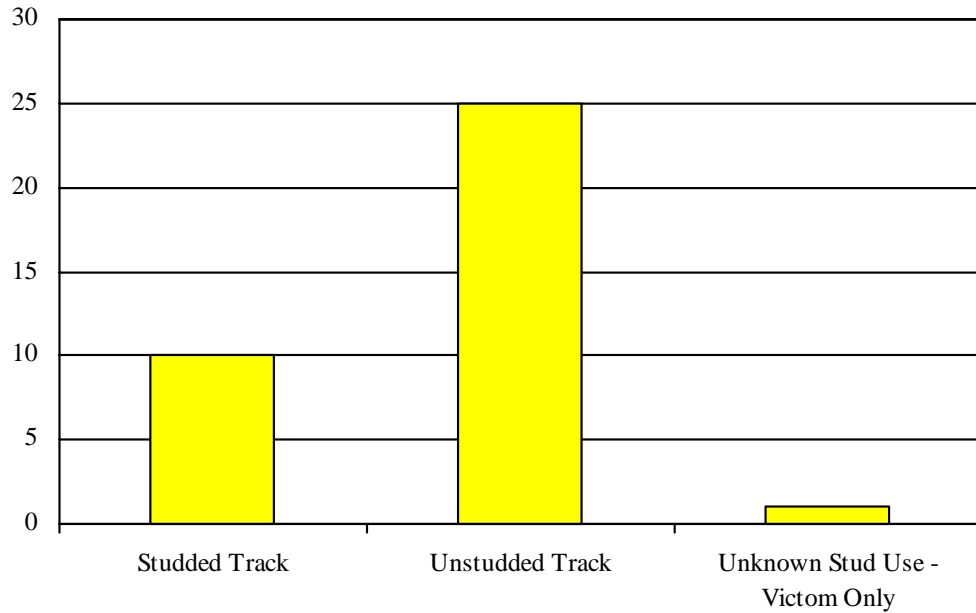

A survey of snowmobilers conducted in October 2001 indicates that 46.6% of the surveyed snowmobilers used studded tracks.

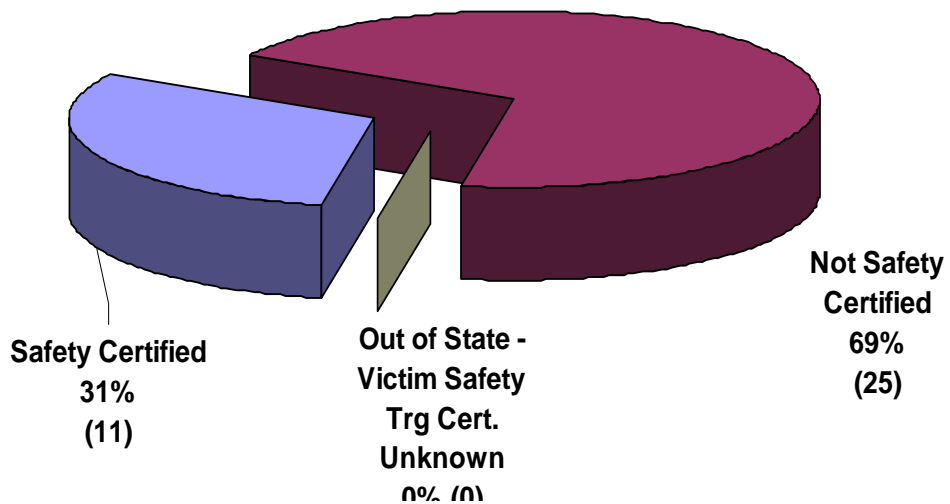
